BDC Studio Rules and Behavior Conduct Contract

Follow studio dress code. Students who are not appropriately dressed for class will be asked to observe.

- No jewelry or gum chewing.
- No food or drink (other than water) is allowed in studios.
- No walking on studio floors with hard-soled street shoes.
- No profanity or fighting. Treat dancers and instructors with utmost respect.
- Arrive 5-10 minutes before class begins.
- Any student arriving 15 or more minutes late will be asked to observe.
- No talking during class.
- Students will be given warning for breaking rules. After that, the student will be asked to leave the class.
- All students, regardless of age, will be expected to maintain a positive professional attitude and strong worth ethic.

I _____ (Student) fully understand and agree to follow all class/studio rules while attending Baltimore Dance Center. It is understood that violation of these rules will result in immediate dismissal from Baltimore Dance Center without any reimbursement for tuition.

Class Tuition and Policies

Cost: \$55/month for 1 hour class or \$15 drop-in fee/class
\$75/month for 1.5 hour class or \$20 drop-in fee/class

Important Policies:

- Tuition is due the first class of each month
- All dancers must sign in every class; dancers under the age of 18 MUST be signed by an adult.
- A \$10 late fee will be added if the payment is not received by the 7th day of each month, regardless of absence.
- A 10% discount will be given to any student or family taking three or more classes per month.
- Months with holidays are still considered full months.
- All returned checks will be charged a \$35 fee.
- No refunds will be given for registration fee or deposit, tuition, early withdrawal or absences.
- Give BDC a written notice two weeks prior if your student should decide to withdrawal for any reason.
- We do not prorate tuition.
